#### PRODUCT DESCRIPTION

The ST Circulator is designed for the circulation of a liquid within central heating systems and offers constant pressure or ability to continuously measure the system pressure and optimise its performance within the selected pressure setting.

# **APPLICATION**

The ST 15/60 B is designed to constantly circulate hot water within an open system. The ST 15/60 & ST 25/80 are designed to constantly circulate hot water within a closed loop system.

#### **STORAGE**

If this product is not to be installed immediately on receipt, ensure that it is stored in a dry, frost and vibration free location in its original packaging.

#### **WARNINGS:**



- This appliance can be used by children aged from 8 years and above and persons with reduced physical, sensory or mental capabilities or lack of experience and knowledge if they have been given supervision or instruction concerning use of the appliance in a safe way and understand the hazards involved.

- Do not run the pump dry.
- System pressure must not exceed 10 bar.
- Before starting work on the electrical supply ensure power supply is isolated.
- DO NOT allow the supply cord to contact hot surfaces, including the motor shell, pump body or pipework. The cord should be safely routed and secured by cable clips.
- This appliance must be earthed via the supply cord, which must be correctly connected to the earth point located in the terminal box.

Please read installation details carefully as they are intended to ensure this product provides long, trouble free service. Failure to install the unit in accordance with the installation instructions will lead to invalidation of the warranty.

#### 1 PUMPED MEDIUM

- 1.11 For normal operation of the pump it is necessary to use clean water, or a mix of clean water and antifreeze. This should be suitable for central heating system's and in accordance with the current standards such as EN 1228. The liquid must not contain agressive or explosive supplements, mineral oils and solid or long fibres.
- 1.12 The pump must not be used for transfer of flammable and explosive liquids or in an explosive atmosphere.
- 1.13 Temperature of medium should not be lower than ambient temperature to avoid condensation forming on the pump.
- 1.14 Operation outside recommended conditions may shorten pump life and will void the warranty.

#### 2 INSTALLATION

2.11 The pump must be installed with the motor shaft in the horizontal plain (Fig. 1) allowing the flow through the inlet/outlet to be either vertical or horizontal (Fig. 2).

Note: The arrow on the pump case indicates the direction of flow.

## Pump terminal box


If the pump is installed where access to the terminal box is limited it can be repositioned in the following manor (Fig. 3).


- Isolate pump from the water services using 1½ " pump valves.
- Isolate power.
- With pump key remove four retaining screws.
- Pull motor/terminal box assembly away from pump body.
- Rotate motor terminal assembly box to desired position.
- Re-install using instructions above in reverse order ensuring sealing 'O'-ring correctly located.
- 2.12 Before starting pump, open pump valves and bleed system through. Pressurise system to suit.

Any trapped air in the pump may cause excessive noise when started. If it does not clear after 1–2 minutes of running, stop and start pump.



- Note system pressure must not exceed 10 bar.
- Do not run the pump dry.
- The pump casing will get hot as the liquid temperature rises, and must not be touched.





### 3 ELECTRICAL INSTALLATION / EARTHING



- 3.11 **Regulations:** The electrical installation must be carried out in accordance with the current local regulations by a qualified person.
- 3.12 **Safety:** In the interests of electrical safety a 30 mA residual current device (**R.C.D. not supplied**) should be installed in the supply circuit. This may be part of a consumer unit or a separate unit.
- 3.13 Before starting work on the electrical supply ensure power supply is isolated.
- 3.14 **Earthing:** This appliance must be earthed via the supply cord, which must be correctly connected to the earth point located in the terminal box.
- 3.15 **Cable fitting:** The pump must be fitted with 3 core 1 mm<sup>2</sup> HO5 RR-F or equivalent cable and permanently connected to the fixed wiring of the mains supply using the factory fitted supply cord, via a dedicated double pole switched fused spur off the ring main.
- 3.16 DO NOT allow the supply cord to contact hot surfaces, including the motor shell, pump body or pipework. The cord should be safely routed and secured by cable clips, alternatively the cord must be protected by an insulating sleeving with appropriate temperature rating.
- 3.17 Wiring of connection unit:



# WARNING: This appliance must be earthed.

The wires in the mains lead (supply cord) are coloured in accordance with the following code:


Green and Yellow: Earth (PE)

Blue: Neutral (N) Brown: Live (L)

As the colours of the wires in the mains lead of this appliance may not correspond with the coloured markings identifying the terminals in your connection unit proceed as follows:

- The wire which is coloured green and yellow must be connected to the terminal in the connection unit which is marked with the letters PE or by the earth symbol: 

  or coloured green or green and yellow.
- The wire which is coloured blue must be connected to the terminal which is marked with the letter N or coloured black.
- The wire which is coloured brown must be connected to the terminal which is marked with the letter L or coloured red



3.18 **Fuse:** All models should use a 5 Amp fuse.

#### **4 PUMP SETTINGS**

- 4.11 This pump has three different preset curves with proportional pressure, or three curves with constant power available by pressing the button on the terminal box cover consecutively.
- 4.12 The button illuminates to indicate the performance selected.
  - Blue lowest power
  - Green medium power
  - Yellow highest power
- 4.13 To select the desired pressure with proportional pressure (optimising pump performance to the system requirements) press the button down >5 seconds, the light in the button will now pulse faster slower depending on speed of the pump.

Press the button again in short succession until return the pump to constant power mode, the light will then shine constantly while in this setting.


# **6 TROUBLE SHOOTING GUIDE**


Symptoms	Probable Cause	Recommended Action
Indicator light is off, pump is not pumping any water.	No power.	Check electric installation and fuses.
Indicator light is permanently on.	The unregulated performance may have been chosen	Choose regulated performance.
Indicator light changes colour.	Pump is blocked.	Clean pump.
Sounds and noises in the system.	Pump or system is not appropriately vented.	Vent the system.
Too low water flow rate.	The selected setting is too low.	Select a higher performance.
